- Your submission of the proposal form and your paying of the premium and/or other related fees, including document duty, do not imply that your proposal is accepted and your contract inception. When your proposal is accepted, the date of inception of your contract shall be shown on your policy document.

- Citadel does not have a holding, direct or indirect, representing 10% or more of the voting rights or of the capital in the tied insurance intermediary;
